

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the Fomo app, havefomo.com and ViperQ, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ViperQ, LLC include the Fomo app, havefomo.com and ViperQ. ViperQ is a nightlife information app. By using ViperQ, you consent to the data practices described in this statement.

## Collection of your Personal Information

ViperQ may collect personally identifiable information, such as your name. ViperQ may also collect anonymous demographic information, which is not unique to you, such as your age, gender and location. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by ViperQ. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of ViperQ.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through ViperQ's public message boards, this information may be collected and used by others.

ViperQ encourages you to review the privacy statements of apps and websites you choose to link to from ViperQ or the ViperQ so that you can understand how those websites collect, use and share your information. ViperQ is not responsible for the privacy statements or other content on apps and websites outside of ViperQ.

## Use of your Personal Information

ViperQ collects and uses your personal information to operate its app(s) and deliver the services you have requested.

ViperQ may also use your personally identifiable information to inform you of other products or services available from ViperQ and its affiliates. ViperQ may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

ViperQ does not sell, rent or lease its customer lists to third parties.

ViperQ may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. ViperQ may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ViperQ, and they are required

to maintain the confidentiality of your information.

ViperQ may keep track of the websites and pages our users visit within the ViperQ, in order to determine what ViperQ services are the most popular. This data is used to deliver customized content and advertising within the ViperQ to customers whose behavior indicates that they are interested in a particular subject area.

ViperQ will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on ViperQ or the site; (b) protect and defend the rights or property of ViperQ; and, (c) act under exigent circumstances to protect the personal safety of users of ViperQ, or the public.

### **Security of your Personal Information**

ViperQ secures your personal information from unauthorized access, use or disclosure.

### **Children Under Thirteen**

ViperQ does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use ViperQ.
